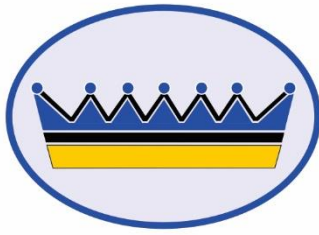

America, you have to survive.

A call to action

Of all the issues facing the United States of America at this time, none are more important than restoring election integrity and confidence in the electoral process.

As a Social Strategist (one who recognizes injustice and sees God's solutions in society where evil and tyranny are blatantly evident) for twenty seven years, and one who embraces a biblical worldview, I felt constrained to write this white paper as an urgent call to action, to sound the alarm, and to unite the faith-based community to see America Restored by urgently addressing the integrity of the recent Election. The attitude of nonchalance – simply doing nothing and letting America slide into destruction – cannot be afforded.

1) INTRODUCTION.

The evil, tyrannical global thrust to dominate America goes back to decades. However, the drive to dominate America became clearly evident during the November 2020 elections.

Now that we have had both domestic and foreign election interference, it's no longer Republican versus Democrat or liberal versus conservative, but evil versus good.

The majority of Americans see both political parties at fault, involving fraud on an unprecedented scale in the history of the nation.

As of July 2021, an independent researcher developed a Citizen Action Election audit system that uncovered approximately 18 million fraudulent votes. As of July 2021, we have engaged with senior legal experts who are using forensic election experts to validate the numbers

uncovered. The scale of the theft is unimaginable. Blatant fraud and corruption have been noted in both domestic and foreign interference, thereby abrogating any possibility of free and fair elections in the US.

During 2020-2021, all forms of legitimate legal and legislative steps were taken countrywide to bring fraudulent US elections to the attention of the judicial system, but they refused in most instances to hear such cases, thereby revealing that the justice system is also compromised as they are unwilling to defend and uphold the constitution.

We believe that the current president, House, Senate, and Supreme Court are all compromised and have thus failed the American people and the constitution. They can no longer be trusted.

From July 2021, all such legal remedies that we are aware of, have been exhausted.

Voter Integrity v Voter Suppression

Lastly, the immigration problem is much worse than anticipated. According to the 2020 census presented by the US government, only 50% of people in the US are US citizens. There are in excess of 87 million legal immigrants (not yet citizens) and more than 21 million undocumented immigrants.

Now, one can clearly see why the enemies of this country are pushing the notion of voter suppression to retain power. What is clearly needed is election integrity, the only path to free and fair elections, where only US citizens can vote only once. The enemies of the US want everybody to vote, no matter who they are. The reason is plainly obvious – to retain power at any cost through sheer numbers.

2. OUR VISION: Where we are going?

- Taking America Back.
- God-honoring governance globally, based on free and fair elections.

3. Mission: How we are going to get there?

- **RRR- Raise Righteous Rulers** - devoted citizens, who hate dishonest gain, elect people of skill, integrity and good character (with a good track record). If we govern right and live right, we will live peaceable lives with the blessings of God. Living in peace is a common goal that we strive for.
- Embark supporting the “Taking America Back” RV Road trip
- Partner with other organizations willing to work together.
- Assist partner organizations to mobilize at the grass-root level
- Assist legislation activities.
- Establishing a moral voice and value system through the Global Liberty Charter, a blueprint for good governance.
- Synchronize media messaging among partner organizations.
- Synchronize voter guides nationally.
 - Build a global network of countries, churches, businesses, organizations, political activists, and individuals who share the same values
 - Help to set up a central funding mechanism to support partner organizations.
 - Help establish a national legal fund in defense of partner organizations and enable them to go on the offensive.
 - Help set up candidate screening mechanisms independent of political parties.
 - Help with Citizen Action election audits.

4. Background

Following the defeat of the conservatives in the 2020 last elections, in the past few months I met with ministry leaders and pastors, an amazing and energetic group, to discuss what was needed to restore America into the hands of the conservatives.

I listened with interest to the different strategies espoused by the many speakers. Yet, the simple strategy of the communists was forgotten – “it matters not who votes, but who controls the counting of the vote.” The majority of people in the US now believe that the vote was compromised and stolen.

There is a determination, not previously evident, to now work together and turn the US around from its current path of decline.

The nation must acknowledge the fact that as conservatives, we have lost most battles and won only a few, and that if the same old modus operandi was perpetuated, the US will continue the downward spiral. Powerful forces of darkness are working tirelessly and efficiently to undermine the Constitution and all godly influences and our rich heritage. The deep state and globalists have identified the weaknesses of the conservative movement and have capitalized on our disunity and fragmentation, while they remain united in purpose.

These weaknesses are:

4.1) The Church

Having had 15 years' experience heading up a ministerial association in Northern Virginia, I conclude the following:

- There is generally very little difference between the secular world and the church.
- The church has generally lost its relevance and voice in society as most operate as isolated, independent works with only a few willing to recognize, work with, and pray together. Great division exists and the fragmentation continues to add to our weakness. Sadly, many still view other churches as competitors.

- Covid-19 has exacerbated the situation. Many churches closed, were silenced, were prohibited from gathering, and were subjected to governmental overreach in controlling them. Sadly, churches were not recognized as essential services. Pastors largely lost their voice due to tyrannical governmental control. On account of fear, most of them became tyranny-compliant and were thus afraid to speak out. The overall result was that the Christian voice was greatly hindered countrywide and globally.
- However, the good news is that a great awakening is occurring as people become informed and awakened to the pending threat of the destruction of America.

It is heartening to see more and more pastors plucking up courage to speak out and resist tyranny, while uniting with others as the real patriots of America emerge. These courageous pastors have the same spirit as the early pioneering pastors who became known as the Black Robe Regiment during the American Revolutionary War against England.

As the courageous pastors stand up and speak up, their stance will help motivate others to do the same. Change always begin with a small, committed group of people who are willing to get involved. Their actions will be catalytic to transform America.

4.2 Non-Profit organizations

- America has a wealth of passionate people who lead nonprofit organizations. These people are experts in their fields and make a significant difference in society. Most of these organizations, both large and small, all generally experience a common challenge - a lack of financial resources. We have observed that many organizations spend most of their time and energy raising funds, which often results in a detraction from their main focus.
- Renowned educational institutions such as Christian universities and colleges are generally more financially secure, but they, too, are coming under increasing attack for being faith-based learning institutions.

Compounding the problem is their parochial attitude in viewing the others as competitors and thus seldom work together.

- All these organizations, much like the church, generally have the same common weakness. Although generally unspoken, this group also operates in isolation and views one another as competitors, especially for funding, and often from the same sources. They are protective of their branding and only a few are willing to work with others.
- One example where competition is evident is voter guides during elections. Many organizations create their own voter guides under their own branding and promulgate what they perceive to be their own value system and thereby raise funds for their programs. It's everybody for themselves. The result again is fragmentation, mixed messaging, and disunity resulting in a confused electorate.

The enemies of America, both foreign and domestic, work together in unity and synchronize their messaging in all spheres of society. They are united in purpose to destroy and control this great nation, and they have been quite effective to date.

- Globalists and the deep state have been extremely effective at using Covid-19 to control the US and the world. It is surprising to observe how poorly informed and gullible society is, and how easy it was to use tyranny to capture and control populations.
- Conservatives, on the other hand, have a track record for a lack of unity that has fragmented and attenuated our position. They have failed to learn from the effective and united efforts of the enemy working under our noses. However, all is not completely lost. There are a few pockets of unity and cooperation that can be replicated and built upon.

5) Societal Challenges.

5.1) Voting machines.

Voting machines have been most likely used in all 50 states. These have made the process of tabulation both suspect and vulnerable to fraud.

Both domestic and foreign interference in this process have exacerbated the problem.

5.2) Justice System

The Justice System is generally corrupt. The courts have largely refused to register complaints of election fraud. Even the Supreme Court is generally considered contaminated and in the pockets of the deep state and globalists. Protection under the law is unjust, and little protection is afforded for our Constitution, country and we, the people. The courts are supposed to function as safeguards, but sadly, they are not.

“We the people,” in all fifty states, are the last safeguard to protect our Constitution and country.

The courts abdicated their responsibility on elections and voter fraud. The Supreme Court was the second-last line of defense but it failed us, the people, because of fear and intimidation by Chief Justice John Roberts.

However, on other matters, the almost 300 judges that the last administration appointed are making a huge difference on religious liberty matters, and the sanctity of human life. Most recently, the Supreme Court *unanimously decided* to uphold the Fourth Amendment to the Constitution on unlawful search and seizure, even involving the ownership of two guns.

It is discouraging but not over. The conservative-leaning Supreme Court is the reason the Democrats tried unsuccessfully so far to *pack the Court*. Democrat US Senator Joe Manchin, from West Virginia, stated that his vote needed for a majority in the US Senate would not be for court-packing. There have been gains against overreach by state and local officials to deny the First Amendment to churches during the shutdowns. It's slow, but there are significant wins by Liberty Counsel, Liberty Institute, Alliance Defending Freedom and the Thomas More Law Center, just to name the big four. They all work free of charge on the Federal, State and local levels to defend individuals, churches and organizations concerning religious liberty and Biblical values. These legal institutions also need more funding to increase their effectiveness.

5.3) As stated previously, most churches, organizations and conservatives lack unity and are generally weak and fragmented. Consequently, their/our voices are largely silenced by the teeming opposition. The deep state/globalists are way ahead of us and have captured the media and educational institutions, using everything at their disposal to leverage our being silenced in every sphere.

5.4) Conservative groups do not have synchronized messaging while the enemy of our country do, and are united, well organized and funded.

5.5) Conservative voter guides are not synchronized. This results in redundancy of effort and cost.

5.6) Conservatives have no unified value system that covers most spheres of society. We have the option of either being ruled by communist, secular tyrants with their own worldview system that tends to use tyranny as its method of control, or we can use a biblical worldview and be ruled by people of skill and integrity who have good moral and spiritual values.

Scripture tells us: ***“When the righteous rule the people rejoice, but when the wicked rule, the people groan.”*** Right now, the nation is in a state of groaning.

5.7) We have no unified, non-aligned, candidate-screening mechanism in the electoral process that can ensure that candidates with the highest integrity and good moral values be elected.

5.8) We have a gross lack of visible leadership emerging. Most people are fearful of intimidation and are thus silent.

5.9) Most people have no hope and are thus without direction.

5.10) A lack of coordinated funding strategy has resulted in organizations being underfunded and thus operate far below their fullest potential. Most struggle to survive.

5.11) There still exists “*the good ol’ boys’ club*” in the Republican as well as the Democrat Parties, as well as many RINOs (Republicans In Name Only) still remain, weakening conservative influence and who therefore need to be removed.

5.12) Media and large corporations are predominantly in the hands of the deep state/globalists.

- 5.13) Concern is evoked in the oversight of voter registration, the voting process and the re-vetting of citizens as significant challenges. These areas of responsibility are potential targets for information fraud and will therefore need to be handled very carefully. These are delicate matters as the responsibilities for these are distributed across 50 states as they gather their representatives from their citizens. The approach to these processes needs to be well thought-out and an implementation strategy proposed. This is one of the major areas of concern.

6) Critical Success Factors

6.1) For the M7 Global to be registered as a non-profit 501(C) 4 organization by September 2021.

6.2) Demand a forensic audit in all 50 states.

Some forensic election experts and researchers predict that the 2020 election results will be subject to further forensic analysis. One interim report shows all 50 states to be contaminated.

President Trump :	92,607,928 votes (59%)
Biden:	62,898,128 votes (41%)
Total	155,506,056 votes (100%)

A minimum of 18,384,970 potential votes should have gone to President Trump.

6.3) Equal Voice, joint ownership.

We have already pointed out that conservatives generally have a poor track record of working together in unity because of our competitive nature and fragmentation of our organizations, businesses and churches.

- **If any one existing organization took the lead in starting an Election Integrity Movement, it will generally fail because others will most likely only give lip service at best and will generally not participate, thereby minimizing the influence and effectiveness of such an organization.** The visionary organization would also have the task of raising most of the financial resources, which again will limit their overall effectiveness and influence on society.
- Nehemiah-type leaders need to step forward and help rebuild the United States of America.

One answer to seeing America Restored is to create a new movement where no one organization is in control, but where **select** organizations come to the table with an equal voice, offering help in their sphere of influence and thereby strengthening the message and effectiveness of the campaign. We can do more together than alone. It also makes good financial sense to help spread the load.

6.4) Why a Global movement?

As the topic of Election Integrity deals predominantly with the sphere of government, the following is important:

- The greater the number, the greater the impact and influence of the group is likely to be in the governmental sphere. Help with professional skills, cohesiveness, and a clear, simple vision, along with **strategic assistance** that lends impetus, is needed.

Two examples:

- There are several groups in Africa and, collectively, these leaders represent about 50 million members currently. Over the next five

years, it is possible to attract leaders with 500 million potential members to our cause.

- Another opportunity is in Europe. The World Freedom Alliance was recently established in Europe and globally to address the tyranny resulting from Covid- 19. Thousands of doctors, scientists and legal professionals have banded together to protect their freedoms.

I have already reached out to this group to explore how we could work together for mutual benefit. Our support will help increase their influence in Europe and vice versa; their support will simultaneously swell our overall influence in America.

6.5) Messaging:

- Opposing VOTER SUPPRESSION at every opportunity with Election Integrity in mind is vital. In fact, being constantly proactive with the message of Election Integrity will serve the movement well.
- Learning from those who hate and are against America. We need to quickly learn the art of centralizing and synchronizing our messaging so that we are all saying the same thing at any one time. Each organizational or business partner, who joins the movement, will have access to privileged information that must be disseminated collectively and most effectively to leverage our strategic objectives.
- The Left organizes themselves through relationships **selected** and **trained** by the Saul Alinsky entity, the Industrial Areas Foundation based in Chicago. The most famous book on the subject is *Rules for Radicals* by Saul Alinsky, but one of the most important ones is *Roots for Radicals: Organizing for Power, Action and Justice* by Edward Chambers, Alinsky's former key organizer. Then, there is *Cold Anger: A Story of Faith and Power Politics* by Mary B. Rogers, which details how a local Alinsky Organization mobilized to change San Antonio, TX. These three books explain how the Left

organizes and why they are so successful in doing the things we have outlined as strengths on the Left vs. weaknesses on the Right. They teach that *anger* is the characteristic most crucial in effective leadership. They agitate with anger, and strategy at work can be seen in several visible leaders and organizations that have been trained and coordinated today.

- The good news is that although the enemy has hindered our voices, they have not silenced us. New, innovative ways to communicate can be created and utilized to circumvent traditional media sources. This can be accomplished through IT specialists as well as a cohesive group of leaders connected to wider and wider circles of influence.

6.6) **Centralized funding needed.**

We need to create a centralized funding program, which has the ability to produce millions of dollars each year that will be used to run this program and support hundreds of partner organizations that have viable strategic projects in their sphere of influence. All these organizations must work together for good in support of the overall vision. This will reduce the stress of fundraising for hundreds of our partners who meet the qualifications for funding support, and by so doing, enable those organizations to focus on their mission and be more effective.

6.7) **The legal battle**

In the last few years, enemies of our country and Constitution have been targeting small groups with legal action to assert their secular /communist belief system, especially where it does not suite their narrative. In many cases, these legal cases are destroying many organizations by the sheer enormity of legal costs, not to mention the emotional, psychological and physical strain placed on people and their families.

These actions have emboldened the enemy, and they are now setting their sights on larger institutions such as Christian universities, businesses, and nonprofit organizations that pose a

threat to their lifestyle and belief system. Therefore, it is safe to say that many conservatives and people of faith are predominantly in a defensive mode right now.

To win this war, it now becomes imperative that in addition to defending ourselves, it is essential to go on the offensive. This would require the best legal minds in the country to be brought aboard to support this movement. A substantial central fund is needed to fight these legal battles in all fifty states, if necessary.

6.8) **Form of Government**

A Republican form of government needs to remain in the USA. We clearly are not a democracy.

The crown has seven points, representing the seven spheres of influence in society.

Those spheres are:

- Business
- Government
- Family & Health
- Religion
- Media
- Arts & Entertainment
- Education

6.10) **Voter guides.**

There are a number of organizations that have gained considerable skills and have developed software that could be used nationally to create voter guides during elections. With this technology, it is possible for all groups to come together and synchronize messaging, candidate questions, method of determining viability of candidates, etc. I propose that all the key groups come together to consolidate ideas and technology and provide one unique system by which all organizations can still incorporate their own branding if required, thereby eliminating the competitive element and sending a clear message that *we the people are united.*

6.11) **What value system shall we use- the global Liberty Charter**

Man uses a secular system by which he is accountable to himself and does not acknowledge God. We have chosen a biblical worldview to develop a value system. In 2014, with the help of a specialist team, I authored the US Liberty Charter. In 2019, I wrote the Africa Liberty Charter, a blueprint for good government based on biblical and moral values. I now see the need to rewrite the US Liberty Charter using the seven spheres of influence model. These values could potentially be the universal value system that could be used globally.

6.12) **Screening of candidates.**

A unified mechanism for screening candidates who are totally independent of all political parties.

Once the movement has gained numbers and influence, candidates will realize that they will need to go through the screening process if they want the people's vote. Candidates would need to state their position in writing – their standing in relation to the Global Liberty Charter Value System, and further agree that should they deviate from those values in their voting records, they can be recalled. Those values will emerge in the voter guides.

6.13) **Grassroots Mobilization**

Goal:

- Build a cohesive and effective coalition of trusted relationships of selected, capable leaders among our partner organizations, who know how to work together, navigate the political arena and empower relational capital. Policy experts already work together in varying degrees across the nation, but there is not a mobilization strategy to turn their policy expertise into votes. It is essential to have diversity in the cohesive core.
- Build a similar infrastructure on the state level to galvanize organizations with a grassroots vision. While it's important to continue to focus on governors, the US Congress and state legislatures, the local level, especially the school board, is where strategic battles are heating up.

Grassroots mobilizing organizations, including Hispanic, Black and Asian leaders, should be synchronized with the strategy to build a county operation to:

- Network with likeminded organizations on the state and local levels.
- Build a church network of individuals in as many churches as possible to work under the authority of the pastor to educate them on policy issues and deliver nonpartisan, clear and effective voter guides in various languages.

- Distribute hard-copy voter guides with an app containing a mapping system with all the churches in an area. This process will be run by paid personnel who will hand-deliver voter guides to each church in the district. This process will set the voter guides apart from others in the nation, and these will be primarily accessed electronically by people who have signed up.
- Convene events with key pastors and influencers in the various spheres of society. The event will not only educate but will survey the leaders to activate them to do several things, including recruiting candidates. Pastors are in a unique position to recognize skilled individuals with integrity in each sphere, whose families are in order and who have potential to serve well in elective office.

The Founding Fathers believed that *able* leaders should be recognized and *selected* to run for office rather than volunteers .

- Build a training system (including videos, streaming, social media and written materials) on the core level that can be used at state and local levels to train on:
 - How to build a local network of leaders who will work together and not care about who gets the credit
 - How to recruit candidates?
 - How to run for office?
 - How to mobilize in a nonpartisan way for state, local and General Elections?
 - How to build relationships with elected officials?
 - How to educate them on issues and hold them accountable? This is where the policy experts come in.

6.14) Voting and Removal of all existing voting machines.

When cancer sets in, everything is contaminated. In order to restore voter confidence, we must firmly demand that all existing machines in all 50 states must be removed. Voters have no confidence in existing technology as they are susceptible to both domestic and foreign interference/fraud. I understand that new,

safe technology is available, but that will be required to be proven and tested first.

From an implementation standpoint, for now, we need to expect that the 2021 elections will generate the result the enemies of America demand. In many cases, they will generally use the same technology. However, time is against us.

We need to place a clear strategy by the end of 2021 - how to remove existing, potentially fraudulent machines in preparation for 2024 or before.

Thereafter, for 2024, we need a new, safe election technology installed that protects our vote and satisfies the demand for free and fair elections.

6.15) **Election voter data base is corrupted.**

As radical as this sounds, if we really want to address the problem of the contamination of the voter election registration system, then we, the people, must express our total lack of confidence in it. The solution, then, is to compile a brand new data base system, and to ensure that every American registers, as far as possible. Fixing the existing system is far too risky as the data is contaminated beyond repair and can no longer be relied on. The solution strategy needs to be in place before the end of 2021.

6.16) **Qualified Voters**

We have to be pre-qualified to drive a car in order to obtain a driver's license.

Similarly, new US citizens must go through a strenuous screening process - must pass a test about US history and learn about the different forms of government to pre-qualify as US citizens, irrespective of age, race, or political affiliation.

Yet, when anybody in the US qualifies to vote on account of age, there is no pre-qualification to take on the most responsible role of appointing our leaders who decide how we live.

As a minimum requirement, every new voter (immigrant citizen) of age, needs to pass the same test. They should also be required to pass the 100-question test. The DMV can easily be linked to conduct such a test. Young people graduating from high school are largely uninformed and ill equipped to be voters.

6.17) Demand each state conduct a forensic audit on the 2020 elections as other states are now doing.

7) **Cost to implement initial start up phase.**

Mobilization and organizational implementation - \$100 million per year for ten years starting January 2023 or before

8) **Next steps.**

8.1) June 2023 - release of final draft to potential organizations inviting comment and suggestions to refine even further.

8.2) 2023/2024 Budget \$1 billion

8.3) 2023 Widespread consultation with potential partner organizations.

8.4) 2023 - Obtain letters of buy-in from potential partner organizations that will include education institutions, non-profits, other organizations, churches/faith community, businesses, activist groups and individuals

8.5) Establish board by June 1, 2023

By sept, 2023 - prepare a strategic plan for all partner organizations with budgets for the next three years.

9) Conclusion

- Edmond Burke once said “The only thing necessary for evil to triumph is for good men to do nothing.”
Let it not be said of us that we sat back and did nothing while our country went into decline.
- We are in a state of war to defend our country and it is all hands on deck to help in any way possible.
- **Take a look around... Rome is burning!**
Do you see what’s happening in the world? Have you seen the craziness in France or the insanity in Australia? (Not to mention the Afghanistan debacle!) The country of my birth, South Africa is being destroyed. The whole world is on a freight train heading towards a bridge that is down.

And there are people I love, and you love, and certainly that God loves, on that train that are as lost as a goose in a snowstorm. And so many of us are silent.

- We’re afraid to bring up Jesus ...Not me!
- We were born for this time! We were hand picked to be alive at this time to be His standard bearer, His ambassador so to speak.
